NOTEWORTHY PROGRAMMATIC ACTIVITY FOR 2024:
OCEAN PAVILION OPENS: THE AQUARIUM'S OCEAN PAVILION EXPANSION OPENED ON
AUGUST 29, 2024, MARKING A SIGNIFICANT EXPANSION OF THE AQUARIUM'S
CAMPUS AND BROADENING THE REACH OF OUR IMPACT. THE OCEAN PAVILION
FEATURES THREE IMMERSIVE HABITATS SHOWCASING THE EXTRAORDINARY
BIODIVERSITY OF THE CORAL TRIANGLE AND, ALONG WITH OUR LOCAL HABITATS
AT PIERS 59 AND 60, EMPHASIZING THAT EARTH HAS ONE CONNECTED OCEAN.
CURRENTLY THE OCEAN PAVILION IS HOME TO ALMOST 200 DIFFERENT SPECIES
AND OVER 5,000 INDIVIDUALS.

SAFE HOMES FOR A SPECIES FACING EXTINCTION: WE WORKED WITH CONSERVATION

PUPS, TRANSFERRING EIGHT TO OTHER U.S. AQUARIUMS AND PROVIDING A HOME
IN THE OCEAN PAVILION FOR ONE AS AN AMBASSADOR. THE BOWMOUTH GUITARFISH
IN OUR CARE, RHINA, MOVED INTO OUR LARGEST OCEAN PAVILION HABITAT IN
SEPTEMBER 2024.

PARTNERING TO RECOVER ENDANGERED PINTO ABALONE: THE SEATTLE AQUARIUM'S
PINTO ABALONE RECOVERY WORK EVOLVED FURTHER IN 2024. FOR THE FIRST
TIME, WE TOOK ON TWO NEW SITES TO OUTPLANT INDEPENDENTLY FROM OUR
WASHINGTON DEPARTMENT OF FISH AND WILDLIFE AND PUGET SOUND RESTORATION
FUND PARTNERS TO EFFECTIVELY EXPAND THE FOOTPRINT OF THE RECOVERY
EFFORTS. MEMBERS OF OUR ANIMAL CARE TEAM RELEASED 1,266 ABALONE THAT
WERE RAISED IN OUR ANIMAL CARE CENTER, AND AN ADDITIONAL 2,224 ANIMALS

PARTNERING ON THE GLOBAL STAGE TO RESTORE AN ENDANGERED SHARK SPECIES: THE STEGOSTOMA TIGRINUM AUGMENTATION AND RECOVERY (STAR) PROJECT MADE FURTHER ADVANCES IN 2024, RELEASING 18 INDO-PACIFIC LEOPARD SHARKS TO THE WILD. THE SEATTLE AQUARIUM CARES FOR INDO-PACIFIC LEOPARD SHARKS BOTH AS AMBASSADORS AND AS BREEDING COHORTS TO CONTRIBUTE TO THE RECOVERY OF WILD POPULATIONS. THIRTY-SIX EGGS CAME THROUGH THE SEATTLE AQUARIUM EN ROUTE TO INDONESIA IN 2024 WITH PLANS TO REAR THE PUPS AND RELEASE THEM INTO PROTECTED WATERS.

LEGISLATIVE ADVOCACY: IN THE WASHINGTON STATE LEGISLATIVE SESSION, OUR POLICY AND ADVOCACY TEAM SIGNED IN ON THE RECORD IN 33 HEARINGS WITH OUR SUPPORTIVE POSITION ON 18 DIFFERENT BILLS. WE WORKED WITH OUR YOUTH OCEAN ADVOCATES (HIGH SCHOOL MARINE SCIENCE VOLUNTEERS) TO PASS A BILL IN THE STATE LEGISLATURE TO DECLARE BULL KELP FORESTS THE OFFICIAL MARINE FOREST OF WASHINGTON, TO RAISE AWARENESS OF THEIR IMPORTANCE AND THE NEED FOR CONSERVATION.

AN AQUARIUM FOR ALL: WE CONTINUED HOSTING OUR COMMUNITY DAYS SERIES, CELEBRATING DIVERSE CULTURES AND ENGAGING THOUSANDS OF GUESTS. EVENTS INCLUDED ASIAN AMERICAN AND PACIFIC ISLANDER COMMUNITY DAY, VAMOS AL ACUARIO!, QUEER COMMUNITY DAY, INDIGENOUS PEOPLES COMMUNITY DAY, AND EID CELEBRATIONS.

CORAL CONSERVATION CONTEST: ELEMENTARY SCHOOL STUDENTS PARTICIPATED IN OUR CORAL CONSERVATION CONTEST. OVER 300 STUDENTS CONTRIBUTED CREATIVE PROJECTS THAT REACHED OVER 8,000 PEOPLE.

BEACH NATURALIST AND CEDAR RIVER SALMON JOURNEY PROGRAMS: OUR BEACH NATURALISTS ENGAGED PEOPLE AT 11 LOCAL BEACHES ON 22 LOW-TIDE DAYS FROM JUNE THROUGH EARLY AUGUST AND ON TWO EVENING BEACH EXPLORATIONS DURING WINTER MONTHS IN 2024. OUR CEDAR RIVER SALMON JOURNEY NATURALISTS ENGAGED VISITORS AT BALLARD LOCKS AND AT SALMON VIEWING STATIONS ALONG THE CEDAR RIVER.

SUMMER CAMP AND SCHOOL PROGRAMS: OUR MARINE SUMMER CAMP PROGRAM HAD 316 PARTICIPANTS, AND ON-SITE SCHOOL PROGRAMS HOSTED 28,741 STUDENTS AND CHAPERONES, APPROXIMATELY HALF THROUGH SCHOLARSHIPS.

CONSERVATION RESEARCH: WE COMPLETED OUR 25TH YEAR OF SEA OTTER CONSERVATION RESEARCH, INCLUDING OUR 15TH YEAR OF SEA OTTER FORAGING RESEARCH. WE ALSO COMPLETED OUR 20TH YEAR OF ROCKY REEF RESEARCH IN THE SALISH SEA, CONDUCTING 16 DIVE SURVEYS ACROSS 12 SITES. OUR URBAN KELP RESEARCH PROJECT WITH THE PORT OF SEATTLE CONTINUED, ALONG WITH ANOTHER PROJECT THAT ALSO USES REMOTELY OPERATED VEHICLES TO BETTER UNDERSTAND THE HEALTH AND POPULATION STATUS OF KELP, INVERTEBRATES, AND FISHES IN COASTAL WASHINGTON. WE ALSO COMPLETED OUR 16TH YEAR OF HAWAII REEF RESEARCH OFF THE WEST COAST OF THE BIG ISLAND OF HAWAII, CONDUCTING SURVEYS ACROSS EIGHT SITES.

WE HOSTED THE 20TH YEAR OF THE NORTHEAST PACIFIC SHARK SYMPOSIUM (NEPSS) WITH OVER 60 TALKS IN THREE DAYS AND OVER 100 PARTICIPANTS FROM CANADA, THE U.S. AND MEXICO. THIS IS THE LARGEST SHARK RESEARCH AND CONSERVATION MEETING HELD REGULARLY IN THE WEST COAST OF THE AMERICAS.

IF THE BOARD IS MAKING A DECISION REGARDING A PRODUCT OR SERVICE IN WHICH A CONFLICT EXISTS, CONFLICTED BOARD MEMBERS WOULD BE RECUSED FROM VOTING ON THE DECISION.

WE USE A MARKET-BASED WAGE SURVEY CONDUCTED DURING A PRIOR YEAR AS A BASELINE TO ESTABLISH COMPENSATION LEVELS. THE COMPENSATION COMMITTEE PRIMARILY CONCERNS ITSELF WITH THE DETAILS RELATED TO THE EXECUTIVE TEAM POSITIONS. THEY DO, HOWEVER, PROVIDE OVERALL WAGE POOL GUIDANCE WHICH IMPACTS ALL AQUARIUM EMPLOYEES. THE ORGANIZATION USES COMPARABLE DATA FROM BOTH FOR-PROFIT AND NONPROFIT WAGE SURVEYS, AS WELL AS THE ASSOCIATION OF ZOOS AND AQUARIUMS WAGE SURVEY TO HELP DETERMINE COMPENSATION. WRITTEN RECORDS ARE MAINTAINED REPORTING THE DECISIONS AND MEETINGS REGARDING THE COMPENSATION PACKAGES. IN 2022, THE AQUARIUM PUBLISHED PAY BANDS FOR ALL EMPLOYEES TO PROVIDE GREATER COMPENSATION TRANSPARENCY. ALL POSITIONS WERE REVIEWED AGAINST MARKET DATA AT THAT TIME TO BE ASSIGNED TO THE MOST APPROPRIATE PAY BAND. THOSE PAY BANDS WERE UPDATED IN 2023, AS APPROPRIATE. IN 2025, THE ORGANIZATION INTENDS TO CONDUCT ANOTHER SURVEY STUDY.
